



## 2008 Recognized Clock Hour (RCH) Program Approval Report

Training appropriate for chemical dependency counselors may not always be appropriate for the prevention specialists and visa versa. Therefore, the Board assigns each program with a letter designating approval for chemical dependency specific (C), prevention (P), clinical supervision (S), diagnostic (D) and field related (R). The letter designation is place behind the PID# (program identification number). For example, 03-123 CSP.


