Twenty percent work experience would need to be in clinical core functions as defined. A. Moss suggested at some point the 20% should be studied further but we should not make changes without studying the data first.

**Substance use disorder:** as defined by the applicable DSM

**Substance use disorder treatment services:** will be defined by Exec. Committee as the term is used in requirements for licensure rules reviewed. A motion will be made to allow for this.
