Mary Wolff is joining the group with a background in coalition work in Clermont Co, and now with Ohio Suicide Prevention Foundation. And Alysia Longmire with years of experience working with UMADAOP in Cincinnati, and also splitting a position with Prevention First.

2. Announcements for the Field

Molly mentioned the training and summits under Ohio Prevention Conference. Summit is May 12th and another Closing Summit for June 22nd.

Jim mentioned ADAPAO conference coming up May 4-6th and there are scholarships available, see Christi Valentini Lackner with Prevention First for details.

3. Directors Update

Jill thanked Jim for including Renewal notice for those under HB404 extension in Monday Mornings with ADAPAO. Jill shared updates from working with CE Broker on new definitions and that some Providers still have courses under F1, F2 that need to be informed they need to reclassify or course will be deleted soon. Also there is no P8 and P7 will become PE. Cultural Competency is CC.

To date: Active Prevention Certificate Numbers (note the 7/1/21 extension may inflated numbers a bit and won't have a real accurate count until after 7/2/21)

4. OhioMHAS Prevention Rule Update (M. Stone)

Molly spoke to some of the issues addressed in the first meeting with OHMHAS Prevention Rules. A lot of discussion on needing to explain the difference between Agency Prevention Certification and Individual Prevention certification. Members of committee also spoke to the need for this communication and to make sure the agency certifiers are knowledgeable and able to guide agencies on what constitutes Prevention services, supervision requirements and staff member certification. Members spoke about faith based and education/higher education exemptions, supplemental services, mentoring , QHMA and social workers not having prevention in their scope of practice yet able to supervise. Members spoke to equal Rules and attention across the Continuum of Care.

5. 24 hours of AOD Requirement

- a. How is this defined and how best to demonstrate on Education Grid
Prevention certificate reviewer from board staff, Mary Noel, joined to share issues with accerning this requirement and a need for a definition.

The Committee is proposing to the board to meet the AOD Prevention requirement of 24 hours , the content of the learning must lead to outcomes /correlate specifically to **substance use prevention**.

So training on prevention education curriculums that have proven outcomes as it relates to AOD prevention counts, Evidence based practices as relates to AOD prevention outcomes, Specific AOD knowledge courses if RELATES back to knowledge needed for preventionists (not clinical)

Jill will work on specific language for the field and for Board approval. Mary departed the meeting.
