Introductions:

Ethics:

J. Smock briefly shared pages from the ethics violation chart that was distributed for Board member review. G. Hogg asked whether treatment intervention in lieu of conviction requires a guilty plea? S. Funkhouser clarified that individuals do not have to plead guilty in those cases unless they don't complete treatment in lieu of conviction.

L. Haywood responded that 4758-8-B2 discusses Unlawful Conduct. Misdemeanors "may" result in disciplinary action, but felonies "will" result in disciplinary action if the felony affects the ability to practice. Misdemeanor language should be added. W. Haynes-Britton requested that this subject be tabled for discussion in the Ethics Committee meeting.

Jill S. reported that the Ethics Logs was collecting data as to the following categories : sexual, multiple relationships, fraud and impairment. Jill S. asked if there were any other major categories to consider tracking exclusively? Full Board agreed with this distinction.
